Youth Athletics - Roy Sessions

◆ Cross Country Association Championship is November 14, 2009 here in Las Vegas. It is going to be held at the Retention Basin on Tenaya & Gowan. The biggest issue is the timing system. We will do stop watches in the worst case scenario. He advised all that there is no 3K facility here in Las Vegas. Cross Country is going to be bigger this year than ever because the JO's regional's in Nevada this year and it is a week after state. Getting help is an issue because the high school coaches do not want to help. Coach O'Day is the only coach that he has run across that is willing to help out. He will see him on Saturday and I will have to talk to him about helping out. He is still working on Middle School Mania. The Middle School Mania meet went over well however we did not get the number of participants we would like to have had join. Out of 400 kids only 1 or 2 kids actually signed up for USATF. His goal is to do it again. Regional's for Track and Field is going to be work. The timing system is our biggest issue right now. We must get a timing system that works well. If he has to hire an outside timing company to come in to make sure that it goes over well then that's what he will do. Del Sol's Dixon wants to charge us \$10,000 to run the meet. He will fly someone in from Arizona before Cali to do the timing (someone that has no ties to our association). He wants to start forming committee's for Middle School Mania and Regional's. Roy has assigned Ed O'Neal to do the schedule this year. The following is a tentative schedule:

Advised that thing still must be discussed with the President before any decisions can be finalized.

Other Business - Open Floor

◆ Johnny Yancy of UNLV Elite questioned the \$343.75 on the Treasurers Report for Website. He stated that we have the worse website in History. He also requested that he protest the Heat having a meet. He would like the Board to govern all teams the same across the board. He suggested that we have a dual meet for the Middle School Mania so the kids can see how a track meet is actually run.

◆ Ed O'Neal advised and assisted with the schedule. He reported that the meet on 4/3 (meet changed to 4/10/10) was during Easter and Spring Break. He also requested that we find a way that we can have the principal of the school sign off on a meet so that the kids do not lose out. He feels that all teams should know by January 1 if they can get a meet or not. Stated that we still need to find a way to prove that whoever has a meet has secured a facility. He advised that the stealth's do not want a meet, Star Track is suppose to be here and unable to contact Hurricanes. On 6/5/2010 the meet being held will bump heads with the SAT's & The Great Southwest. Suggested that we have a fundraiser meet and all funds raised go towards all athletes that make it to the JO's. He is to follow up and clean up the meet schedule so that it can be posted. Advised that him and Brooks (President) spoke to Tony Stevens at the Senior Games in regards to the timing system for the regional's meet and Tony said just let him know and he will do it.

- ◆ Bobby Bolden from Blazin Onez suggested that we give out paperwork at the Middle School Mania event that has all of the teams contact information and where they hold practice at. He also thought that having a Principal sign off on a form for the meet could hurt some teams in a way.
